Caution - from Auto to Private Health Insurance By Lawrence Nordoff DC

Every private health insurance carrier knows via the re-evaluation code, i.e. 99212, that your patient has been seen previously by the same DC within 3 years, for some condition including a PI case.

When Blue Cross gets the medical records that your patient was recently released as MMI, or pre-injury status, they assume that any continuing care is for "maintenance" care.

Unless the DC has documented a NEW injury or AGGRAVATION after the PI case release, some health carriers may audit the DC records—charging the DC for billing for chronic care.

These audits are costly and invites sate board review if care is not warranted. No problem 'if' the policy allows maintenance care.

PRATICE TIP: many trauma patients are not 'healed" upon PI release.

Payment in Full is payment in full



After years of confusion between 2 state lawsthe courts held that when a person accepts and cashes a check for "payment in full" that constitutes an agreement and is binding.
