#### **Excellent Management by Shant Karayan DC –Burbank- \$650,000.00**

Carol Austin nearly qualified to become an LAX airport policewoman, but her accident with company owned truck driven by defendant changed everything on the 405 Freeway.

Dr. Karayan undertook extensive efforts to help Carol try to finish her LAX airport training. But even after 3 epidural injections her complaints were still livid. Karayan determined that the C5/6 disk was indenting the anterior cord. The DC referred Carol to a neurosurgeon for an anterior discectomy.

#### **Severe tooth issues along with chiropractic alleged–Alameda - \$2,114.00**

Greg Humphrey was struck in the rear in his SUV by another SUV on Route 92. SUV damage was \$1,014. Most unusual was Humphrey's claim of significant injuries to his mouth—which required root canals, extractions, and bridge work—over \$12,000 worth.

St Farm quickly argued that it was physically impossible for any dental damage to have occurred—from such a low speed accident—**no mechanism of injury**. No paramedics or emergency room. That Humphrey's dental problem was from severe long term dental decay. Jury paid DC's bills. St Farm will get court fees. [Alameda Superior Court HG 073 318 65](#), Judge George Hernandez
