# Thoracic Outlet Syndrome: the most likely and UNDERUSED diagnosis for arm numbness

Scenario: your patient develops numbness and tingling 3 weeks post accident, in the right arm down to 4<sup>th</sup> and 5<sup>th</sup> fingers. Her MD orders MRI with no abnormal findings. Symptoms continue and the EMG is normal. Insurance company suspects mental, rather than physically based pain.

Six months post accident patient still suffers arm numbness.



This condition may very well be Thoracic Outlet Syndrome [TOS]. It is easily and inexpensively diagnosed.

Dr Gary Lewkovich DC recommends using the "scalene push test". The DC places moderate pressure over the lower portion of neck muscles and holding the pressure for a period of 10 seconds. If no arm symptoms show up within 10 seconds, you have a negative test.
