Getting Claims Paid ... the ''Modifers'' Issue by Sam Collins - the Billing Expert

Billing problems happen when modifiers communicate that something is *atypical*about a particular claim. Be sensitive because the wrong modifier will say if your service increases or decrease for the patient.

Gonzalez v. City of Santa Ana: Huge Tree Falls Directly on Driver's Roof



Norma is a 28 year-old bright, hard-working graduate from Stanford [full scholarship]. Norma in the only one working in her household; she supports her mother and

grandparents.

After work, she was parking her car on the street in front of her home. Once parked a 100-foot eucalyptus tree fell directly on top of her car, crushing the roof. The impact was severe as the force of energy translated from her head to T5 and T6 fracturing both discs. The City of Santa Ana owned and maintained the tree.

Besides the clear muscular issues, she suffered a mild post-concussion trauma. She was temporarily dazed but not unconscious. However, the chiropractor believed she needed to see a neurologist and psychologist for evaluation. That led to a 2-day exhaustive neuro-psych evaluation by a famous neuropsychologist who teaches at UCLA.

Santa Ana would not negotiate and let this case move to trial. The City failed to maintain an unstable tree, which could have killed Norma. One week before the Mandatory Settlement Conference, Santa Ana hired an outside trial law firm. We were prepared to try Norma's case. Just days before trial the case, I settled Norma's case at the Orange County Superior Court under the watch of the Honorable Judge Melter. After several hours the defendant finally agreed to our demand to pay \$250,000.00. The total medical bills are \$23,000.00.

ACE LIT TIPS

DCs are aware how important quality referrals can be to increase the value of a PI case. Smart referrals greatly



increase the odds of getting your bill paid.

Remember that you are in charge of directing your patient's treatment. Not the HMO, not the attorney, not the insurance company. You are the PI Quarterback. You make all the calls.

With major injury cases, you should use your training to make acute referrals to quality MDs. These can include anything from audiologists and

Q2: For "moderate" MVAs what % of your patients are fully recovered without symptoms after treatment?

Maybe 25%: 31.82% About 50%: 27.27% Mostly recovered:36.36% Nearly 100% get to preaccident health:4.55% ophthalmologists (for patients who present with hearing and vision problems status post MVA), to obstetricians (for patients who suffer pregnancy complications status post MVA), to psychologists and MFTs (for patients who may be suffering from PTSD). Orthopedic and neurological referrals are the gold standard, but you need to know that those MDs are pro-chiropractic. We do not want marginal MDs examining your patients.
